

Sub: Procedure of engagement of Contract Medical Practitioners (CMPs).

In order to avoid delays taking place in actual engagement/joining of Contract Medical Practitioners (CMPs) against the regular vacancies of IRMS, the Joint Procedure Order (JPO) issued in this regard by West Central Railway which envisages the system of monthly walk-in-interviews for selection of CMPs, was circulated to Zonal Railways/PUs for adoption as per their convenience vide Board's letter of even No. dated 28.02.2017 & 28.06.2017.
