**Sub: - Revision of rate of remuneration to Medical Practitioners on Contract basis (CMPs) & revision in honorarium of Part-time Dental Surgeons**

On the subject matter, a copy of the Railway Board's letter No.2017/Trans/01/Policy/Health dt 13.02.18, is sent herewith for information & necessary action, wherein the Railway Board have approved the following: -

**1. For Medical Practitioners on Contract basis (CMPs): -**

- (a) The monthly remuneration payable to CMPs engaged on full time basis on Railway be revised as under: -

Category of CMPs	Monthly Remuneration (in ₹)
GDMO	Rs.75,000/-
Specialist (1 <sup>st</sup> year)	Rs.95,000/-
Specialist (2 <sup>nd</sup> year onward)	Rs.1, 05,000/-
Super Specialist	Rs.1,15,000/-

- (b) All other terms & conditions as laid down in Railway Board's letter No.96/E (GR) II/9/16 dt 23.02.2000 and as amended from time to time shall remain unchanged.

**2. For Part-time Dental Surgeons: -**

- (a) The remuneration payable to Part-time Dental Surgeons working for four hours be revised to Rs.36,900/- per month and for those working for two hours be revised to Rs.18,500/- per month.
- (b) All other terms and conditions, as at present, will remain unchanged.

These orders will take effect from the date of issue of the Railway Board's above mentioned letter and shall remain in force till further orders.



**Sub: Revision of rate of remuneration to Medical Practitioners on Contract basis (CMPs) and revision in honorarium of Part-time Dental Surgeons**

Vide Railway Board letters referred to above, the rate of remuneration payable to Medical Practitioners on contract basis (CMPs) and to part-time Dental Surgeons was advised.

The matter has been reconsidered and the Board (MS, FC & CRB) have approved the following.

**1. For Medical Practitioners on Contract basis (CMPs):**

(a) The monthly remuneration payable to CMPs engaged on full time basis on Railways be revised as under.

Category of CMPs	Monthly Remuneration in Rupees
GDMO	75,000/-
Specialist (1st Year)	95,000/-
Specialist (2nd Year onward)	1,05,000/-
Super Specialist	1,15,000/-

(b) All other terms and conditions as laid down in Railway Board's letter no. 96/E(GR)II/9/16 dated 23.02.2000 and as amended from time to time shall remain unchanged.

**2. For Part-time Dental Surgeons:**

(a) The remuneration payable to Part-time Dental Surgeons working for four hours be revised to Rs 36,900/- per month and for those working for two hours be revised to Rs 18,500/- per month.


(b) All other terms and conditions, as at present, will remain unchanged.


