Kindly refer your letter under reference seeking clarification in regard to the issues pertaining to Replacement panels. Issues raised and necessary clarification thereon is juxtaposed as under:-

S.No.	Issues raised by Northern Railway	Clarification
1.	Whether Replacement panels can be sought from the concerned RRBs against the candidates who do not turn up from previous replacement panel.	Replacement can be sought by the Railway against the non-materialization of a replacement panel, if candidates are available in 30%/50% extra list. However, in no case the number of candidates covered in the original as well as replacement should exceed the number of the vacancies indented by the Railway.

Sub: Clarification regarding placing of demand for 'Replacement Panel from RRB against shortfall.

Ref:- Railway Board's letter No.E (RRB)2002/13/3 dated 08.01.2013 (RBE No. 06/2003, RRCB No. 01/2003) and E (RRB)/2004/3/8 dated 05.05.2006 (RRCB No.8/2006.

Railway Board, vide their letters mentioned above, have issued directives for seeking replacement panels from RRBs in case of Group 'C' posts. According to these instructions, replacement panel equal to the number of candidates finally not turning up for taking appointment will be supplied by RRB to CPO if demand is made within the currency of the panel. This exercise will be done only after CPO satisfies himself that the procedure for cancellation of the offer of appointment to the originally empanelled candidates has been strictly followed.

Although the above instructions are being followed scrupulously by this Railway, a doubt has arisen as to whether replacement panels can further be sought from the concerned RRBs against the candidates who do not turn up from previous replacement panel.

Board, is, therefore, requested to clarify the above issue as demand for replacement panels against not turned up candidates of earlier replacement panels is being received from the Divisions and rules do not clarify such situations
