

**Chapter 1, Section-B, Sub-Section III(III) (Recruitment & Training) –
Rules governing the filling up posts in Transportation (Power) Department**

1. TRANSPORTATION (POWER) DEPARTMENT

(i) ASSISTANT LOCO PILOT, Pay Level-2

- Substitute the following for the existing Para 137(I)(i):-

137.(1) The posts in the category of Assistant Loco Pilot – Pay level-2 will be filled as under:-

- (i) 50% from amongst the volunteering Diesel/Electric Loco Fitters of Diesel/Electric Loco Sheds with three years' service, failing which Diesel/Electric Loco Fitters with less than three years service but total service of six years, Diesel/Electric Loco erstwhile Group 'D' staff of Diesel/Electric Loco Sheds and staff of technicians categories in GP Rs.1800/- working in EMU, DEMU & MEMU sheds with a total service of six years in respective Sheds, having the qualification of course completed Act Apprenticeship in Mechanical/Electrical/Electronic Engineering trade or Matriculation with ITI as an additional preferable qualification with upper age limit of 35 years (40 years in the case of SC/ST).
