

In continuation of Board's letter No. E(NG)I-2013/TR/7 dated 21.09.2015, it has further been decided to replace para 2(iii) of Board's letter No. E(O)III-2014/PL/03 dated 10.06.2014 as under :-

**(iii) For officials of the level II and above in Zonal Railway Headquarters:-**

- (a) One officer of Personnel Branch at least one scale below the Cadre Controlling Authority (minimum junior scale).
- (b) One officer of the concerned Department at least one scale below the Cadre Controlling Authority (minimum junior scale).
- (c) One officer outside the Department at least one scale below the Cadre Controlling Authority (minimum junior scale).


**Competent Authority** : The competent authority to accept the recommendations of the above Placement Committee shall be the concerned HOD.

2. Simultaneously, in supersession of Para 12 of Board's letter No. E(O)III-2014/PL/03 dated 29.08.2014, it is hereby clarified that mutual transfer and one-way request transfer cases may be kept out of the ambit of Placement Committees.
