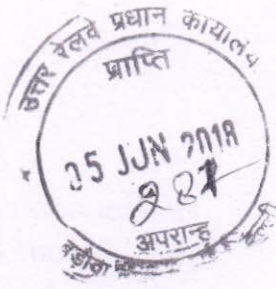



In connection with Board's letter of even number dated 27.02.2018, one of the Federations i.e. NFIR has demanded for giving 90 days time to represent instead of 30 days as allowed in Board's letter ibid, it is advised that the concerned employees may be allowed to represent against grading as 'Good' or below upto 90 days more from issue of this letter.
