Sub : Revised rates of "Diet Allowance to Break Down Staff
Ref : Railway Board letter no.E(F&A)II-2015/f.e-2/2 Dated.27.10.2015

In terms of Railway Board's letter referred above, instructions for providing payment of cash in lieu of free food, in exceptional circumstances to the non-gazetted staff engaged in Breakdown duties were circulated under RBE no.134/2015 dated.27.10.2015 (NR. Ps No.14477/15 dated 03.12.2015)
It has now been decided to revise rates of the "Diet Allowance" for payment of cash in lieu of food to non-gazetted staff i e Accident Relief Train & Accident Relief Medical Van staff including Gangman and Trolleyman engaged / deputed for attending Break Down duties when food cannot be arranged by Railway Administration at the site of accident.Revised rates are as under :

Item	Existing rate	Revised rate
Standard Break Fast (Veg.) with Tea	Rs -18/-	Rs -45/- (30 for Break fast and 15 for tea)
Lunch	Rs -25/-	Rs-110/-
Evening tea with Snacks	Rs -3/-	Rs-45/-(30 for Snackst and 15 for tea)
Dinner	Rs -25/-	Rs-110/-

While making the payments, following formalities may be completed as directed by Headquarter Finance:-

1. It should be ensured that cash should be paid to the non gazetted staff including Gangmen and Trolleyman engaged in breakdown duties only in exceptional circumstances where it is not possible to make arrangement for supply of free food, departmentally or otherwise ,as mentioned in Railway Boards letter RBE No.134/2015 dt-27.10.15.
 2. Proper record of disbursement of diet charges given to the non-gazetted including Gangmen and Trolleyman engaged in breakdown duties in transparent manner may be maintained duly signed by the competent authority ie Officers- in- charge
 3. All Railway Board guidelines/instructions issued in this regard should be strictly adhered to.
- All Divisions / Workshops/ Units are advised to ensure strict implementation of these instruction.
